Procedures	 HTNZ Inc committee determines the scholarship that are to be offered on an annual basis which includes the type of scholarships, number of scholarships, amount per scholarship and the opening and closing dates. Available scholarships are advertised on the HTNZ Inc website and via the HTNZ Inc Gathering Energy members newsletter. Applicants must have registered their interest in the appropriate Healing Touch course and meet the course pre-requisites (if required) prior to applying for a Scholarship for Partial Course Fees. Applicants who are eligible are invited to apply via the approved HTNZ Inc Scholarship Policy, Criteria and Process for Partial Course Fees. All scholarship applications are considered by a committee/advisory group. This group has a Chair. Scholarships for Partial Course Fees are applied directly to the recipient/s Healing Touch NZ current course fees prior to the course taking place. The student pays the remaining difference for the course fee. Once full payment has been received the student's place is confirmed on the course. Scholarships are non-transferable and *are generally non-deferrable. *HTNZ Inc at their discretion may defer a scholarship if there are circumstances beyond the student's or oganisations control e.g. if a course has to be cancelled. HTNZ Inc Treasurer will transfer approved funds from the scholarship account to the course fees account to off-set the course fees and will maintain the record of scholarships. Scholarships cannot be applied for retrospectively. Scholarship permanent residency is required.

Scholarship Committee Process for considering scholarship applications (competitive)

- STEP 1: Applications are received at a certain date/deadline so that all applications are considered at one time to compare (competitive). All applicants are advised that their application has been received.
- All applications are considered by a committee/advisory group. This group has a Chair. All members in the committee have to declare any conflicts of interest and these are acknowledged and managed. The committee has the knowledge needed to evaluate the applications. The steps for them to consider these applications are:
 - 1) Each member of the committee/advisor group looks at each application independently by themselves (before-hand) and scores 1-5 for each application, according to each of the criteria. For each application, the one person already knows that they will be leading out in the next step below. There will be a total overall score for each application.
 - 2) All the committee/advisory group get together and talk about each application. The selected person leads out by talking about the application and then there is a group discussion about it. They then agree (consensus) about the <u>final</u> score for each criteria for each application.
 - 3) Add up **all** scores for each application that has been discussed/agreed upon by the committee/advisory group. This gives a total overall score.
- STEP 3: Based on the total score, each application is then ranked by the committee. Even if an application has the same score, the committee can decide which one is better and it moves up in the ranking.
- STEP 4: Depending on funding, the top applications are then chosen for support.
- **STEP 5:** All applicants are informed of the outcome of this process.

Each criteria is scored from 1 -5.

1 is the lowest, and 5 is the highest. The higher the number scored the higher the ranking of the application. Highest rank applications over all are those who are awarded a scholarship.
